SECTION 4: First aid measures

4.1. Description of first aid measures

General information

SECTION 5: Firefighting measures

5.1. Extinguishing media

Suitable extinguishing media: Alcohol-resistant foam, carbon dioxide, powder, water mist.

5.2. Special hazards arising from the substance or mixture

Extremely flammable aerosol. Pressurised container. In a fire or if heated, a pressure increase will occur and the container may burst.
In use may form flammable/explosive vapour-air mixture.
Fire will result in dense smoke. Exposure to combustion products may harm your health. Closed containers, which are exposed to fire, should be cooled with water. Do not allow fire-extinguishing water to enter the sewage system and nearby surface waters.
