1. Introduction

1.1 General

This information notice explains how data generated by, or collected through, the Aptus System (the "**Product**") is accessed, used, and shared (including server-side software, tenant app and hosting service (the "**Service**")) and how the data is otherwise processed, in line with the requirements under Article 3 of the EU Data Act.

1.2 Product and service description

Aptus is an electronic access control system mainly intended for multi residential installations.

The physical installation with embedded software consists of controllers and peripheral components connected to it. There can be thousands of controllers in the same installation. The peripheral components (e.g. readers, entry phones and booking panels) collect information from user interactions and sends the data to the controller. The controller is making decisions about doors that it manages and creates logs of activities.

For each installation there is also a server installation with software, that is used for configuring and monitoring the installation, typically installed on the system owners server. There are several different software components for different use. "Multiserver" communicates with the physical installation, "Multiaccess Styra" is a configuration and management user interface, "Hantera Styra" for day-to-day administration of credentials and bookings, "Aptusportal Styra" and "Aptus Home" are intended for tenants living in the house. All software modules work against a common SQL-database. The server-side software also collects logs from the installation and presents them to the system administrator. All log data from the physical and software interfaces are stored in the SQL-database.

In the case where ASSA ABLOY Opening Solutions Sweden AB provides a hosting service, the data base is located on the server where the installation is hosted.

1.3 Data holders

The following parties receive data from the Product and/or the Service and may use the data for their own purposes ('data holders'):

- The system owner
- Potential 3rd party hosting provider
- In the case where ASSA ABLOY provides hosting service, ASSA ABLOY Opening Solutions Sweden AB

1.4 Terms of use and quality of service

License agreement for use of Multiaccess server-side software is accepted during the installation process. See appendix A

6. Right to lodge a complaint

If you believe our handling of your data infringes your rights under applicable legislation, you have the right to lodge a complaint with the competent authority in your jurisdiction.

7. Trade secrets

In some cases, data from the connected products or related services may include trade secrets that we or our partners own. Trade secrets shall be preserved and disclosed only where all necessary measures prior to preserve their confidentiality are taken, in particular regarding third parties. In exceptional circumstances, our ability to grant access to data may be limited due to trade secrets. We maintain confidentiality obligations to protect any trade secrets contained within your data.

8. Term and termination

Where ASSA ABLOY provides a hosting service, your contract with us is typically provided on an annual rolling basis, however please refer to your agreement for the exact term.

You may end the contract by following the steps set out in the termination clause of your agreement.
