11. Maintenance requirements

The ABLOY DH006 is a durable brass-based handle, suitable for public places. It is equipped with a return spring. To maintain its proper function and appearance, you should follow these steps:

- Clean the handle regularly with a dilute solution of a mild liquid detergent in warm water. Avoid excessively hot solutions. Use a soft bristle brush or similar to clean the surface. Do not use abrasive tools. After cleaning, rinse surfaces thoroughly with fresh water2.
- Do not use strong solvent type cleaners on surfaces. If you need to remove adhesives or
 other materials from the surface, use the weakest possible solvent, such as methylated
 spirits, white spirits, or Isopropanol. Rinse the solvent thoroughly from the surface and test it
 on a small area before applying it to the whole surface.
 - Lubricate the key cylinder at least once a year or when there are signs of roughness when inserting or retracting the key. Remove any dirt, grime, and salt deposits on and around the end of the cylinder barrel and apply a small amount of lubricant to the key blade and insert the key into the lock barrel.
