10. Installation requirements

11. Maintenance requirements

The maintenance requirements for the LC211 are as follows:

- You should clean the lock case regularly with a dilute solution of a mild liquid detergent in warm water. Avoid excessively hot solutions. Use a soft bristle brush or similar to clean the surface. Do not use abrasive tools.
- You should rinse the surfaces thoroughly with fresh water after cleaning. Do not use strong solvent type cleaners on surfaces.
- You should lubricate the key cylinders at least once a year or when there are signs of roughness when inserting or retracting the key. Remove any dirt, grime and salt deposits on and around the end of the cylinder barrel and apply a small amount of lubricant to the key blade and insert the key into the lock barrel to maintain a smooth action.
- You should inspect the lock case and the door regularly to ensure that they are still in good working order. Check for any faulty hinges, warped doors, or distorted frames that can put excessive load on the lock case and reduce its operating life.
- You should follow the safety and maintenance guidelines to ensure the proper functioning and durability of the lock case.
