#### 2. Product description and its intended use(s)

The ABLOY LC306 Lock Case is a high-security lock case for narrow profile doors that features a hardened steel hook bolt with a 20 mm bolt throw. The lock case is compatible with one-way rotating cylinders and can be operated with a key from either side with a double cylinder, or from outside with a cylinder and inside with a special thumb turn, or from one side only with a single cylinder. The key can only be removed when the hook bolt is fully locked or retracted. The lock case meets the security grade 5 according to EN 12209 and SFS 7020 grade 3 standards.

The intended use of the ABLOY LC306 Lock Case is to provide a reliable and durable locking solution for narrow profile doors in various applications, such as data centres, electric power facilities, finance institutions, healthcare facilities, and other environments that require high levels of security and protection. The lock case can be used with ABLOY PROTEC, PROTEC<sup>2</sup> and NOVEL Cylinders and works with the 4655-striker plate.

#### 9. Design requirements that would support the appropriate use of the building product.

Security mortice lock case (security grade 5 according to EN 12209) with hardened deadbolt and drilling protection. The deadbolt has a 20 mm bolt throw. The deadbolt is locked and retracted by turning the key or thumbturn 360°. The key can only be removed when the deadbolt is fully locked or retract

#### 10. Installation requirements

The installation requirements for the LC306 lock case are as follows:

- The lock case is designed for narrow profile doors with a minimum thickness of 30 mm.
- The lock case requires a compatible cylinder, such as ABLOY® PROTEC, PROTEC<sup>2</sup> and NOVEL cylinders, and a special thumb turn for inside operation if needed.
- The lock case works with the 4655 striker plate, which should be installed on the door frame with screws and aligned with the hook bolt.
- The lock case should be mounted on the door leaf with screws and connected to the cylinder and the thumb turn with a spindle.
- The lock case has a finish of Fe/ZL, which means it is made of steel with a zinc coating. It should be cleaned with a soft cloth and mild detergent, and lubricated with graphite powder or oil.

#### 11. Maintenance requirements

The maintenance requirements for the LC306 lock case are as follows:

- The lock case should be cleaned with a soft cloth and mild detergent, and lubricated with oil or equivalent lubricant.
- The lock case should be checked regularly for proper functioning and alignment with the

- The lock case should be serviced by a qualified technician if it malfunctions or fails to operate smoothly.
